INVESTMENT PROCESS – PREPARATION STAGE

- ❑ Information from the land and building registry
- ❑ Verification of coverage of the investment area with the provisions of the applicable local spatial development plan (MPZP)
- ❑ Verification of the need to obtain a decision on environmental conditions for investments (DUŚ)
- ❑ Preparation of the investment in terms of communication service and its drainage
- ❑ Verification location of investments in areas covered by the municipal register of monuments or entered into the register of monuments
- ❑ Obtaining the decision on the determination of the the development conditions (WZ)/decision on the establishment of the location of the public-purpose investment (ULICP)*

INVESTMENT PROCESS – DESIGN AND PREPARATION STAGE (1)

- Exclusion of agricultural land from production
- Coordination of location of the designed infrastructural network
- Merge of the investment into a public road
- Merge of the investment into a non-public road and location of the infrastructure in the road lane
- Provision of urban areas for the location of technical infrastructure devices
- Permission to remove trees and shrubs
- Derogation from technical and construction regulations
- Conservation permit
- Permits, water and legal reports, permits in the flood protection wall zone
- Approval of geotechnical documentation
- A building permit, notification of construction or construction works with the project
- Notification of the intention to perform construction works



INVESTMENT PROCESS – DESIGN AND PREPARATION STAGE (2)

- Provision of urban areas for the purpose of conducting construction works
- Publication of the construction logbook
- The occupation of the road lane in connection with the investment
- Notification of intention to remove trees
- Assignment of the building with an order number and street or estate names

INFORMATION FROM THE LAND AND BUILDING REGISTRY

The data contained in the extract from the land registry, i.e. the immovable property (plot number, number or name, and registration unit), area, use and class of land, mortgage register number or entry number in the monuments register are particularly important in the planning and implementation of the investment process.

DECISION ON THE CONDITIONS OF SPATIAL DEVELOPMENT (WZ) DECISION ON DETERMINATION OF THE LOCATION OF A PUBLIC PURPOSE INVESTMENT (ULICP)

If the investment area is not covered by the provisions of the Local Development Plan, it is necessary to obtain a decision on establishing the development conditions or a decision on determining the location of the public-purpose investment.

DESIGN AND PREPARATION STAGE



EXCLUSION OF AGRICULTURAL LANDS FROM PRODUCTION

If the area of the planned investment is a land use subject to exclusion from agricultural production - before applying for a building permit, a decision should be obtained allowing its exclusion - from production.

List of lands subject to exclusion from production: Article 11 of the Act of 3 February 1995 on the protection of lands and forests.

Permission to exclude agricultural land from production **does not automatically change the land use in the land and building register. Only the commencement of the investment (first entry in the construction logbook) results in the actual exclusion of agricultural land from production and the need to update the land use data.**



COORDINATION OF LOCATION OF DESIGNED INFRASTRUCTURAL NETWORKS

In the event that the planned investment provides for the construction, extension or reconstruction of the infrastructural network - before applying for building permits or notification of construction works - a settlement on the designed infrastructural networks should be obtained. **Types of infrastructural networks subject to agreement:** Article 28b of the Act of 17 May 1989 on geodetic and cartographic law. The location of the designed infrastructural networks is coordinated at the coordination meetings. The results of the meeting are fixed in the minutes.

GRANTING ACCESS TO URBAN TERRITORIES FOR THE LOCATION OF TECHNICAL INFRASTRUCTURE DEVICES

If, as part of the implementation of the investment, it is necessary to build, rebuild, replace or renovate technical infrastructure facilities located in the areas owned by the Municipality of Kraków or the State Treasury located in the Municipality of Kraków - it is necessary to regulate the entrance to the property.

Paid access to the property takes place on the basis of a concluded contract.

In the case of investments related to the need to remove trees and shrubs, appropriate permits are required. For the immovable properties entered in the register of monuments, the appropriate monument conservator grants permission.

DEROGATION FROM THE TECHNICAL AND CONSTRUCTION PROVISIONS

In the event of derogations from the technical conditions which should be met by a building, obtaining a proper consent is required.

The derogation, in the form of a decision, is issued after the architectural and construction authority has obtained the authorisation of the proper minister who has established technical and construction regulations.

The competent minister may make the authorisation conditional upon the derogation from additional conditions.

DECLARATION OF INTENTION OF CONSTRUCTION WORKS

In the case of some works, it is not required to obtain a building permit, only making a declaration of construction works.

Declaration has to be made before **the planned date of construction works**.

GRANTING ACCESS TO URBAN TERRITORIES FOR THE PERFORMANCE OF CONSTRUCTION WORKS

In order to carry out renovation and construction works, it is necessary to occupy the territories belonging to the Municipality of Kraków or the State Treasury located in the Municipality of Kraków, it is necessary to conclude a contract for paid access to the site.

The procedure does not apply to: buildings managed by the Board of Municipal Buildings in Kraków, the road lane, marketplaces, areas covered by the perpetual usufruct agreement, lease, lending and cast in permanent management.

OCCUPATION OR ROAD LANE IN CONNECTION WITH IMPLEMENTATION OF INVESTMENT

If it is necessary to perform work in a road lane, it is necessary to obtain a permit for temporary occupation of a road lane from the road administrator:

- for municipal, powiat, voivodship and national roads - in the form of a decision,
- for internal roads - by agreement.

NOTIFICATION OF INTENTION OF REMOVAL OF TREES

Before removing the tree, the Environmental Management Department should be informed about this intention.

Applications can only be made by the property owner. In the case of co-ownership, it is necessary to obtain the consent of all co-owners of the immovable property or power of attorney to act on their behalf.

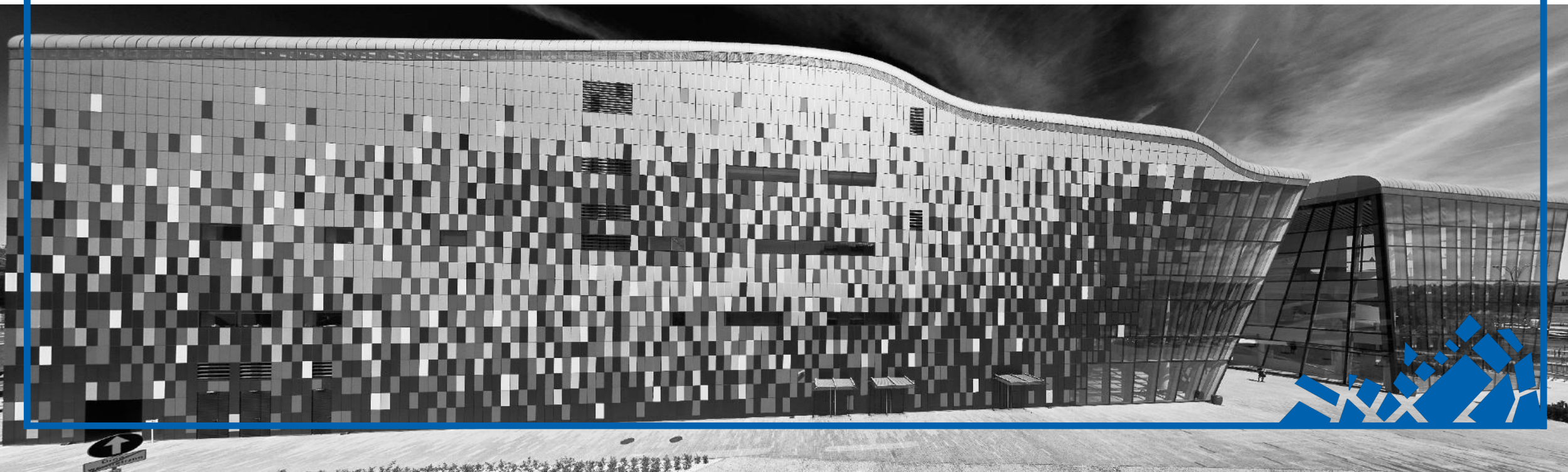
